The Sandown Planning Board meets the first and third Tuesday of every month at 6:30 p.m. The first meeting is a workshop meeting, and all Public Hearing will be scheduled for the 2<sup>nd</sup> meeting.

Applications must be received 21 days prior to a scheduled meeting. Submissions on Tuesdays and Thursday's can be made during office hours and submissions made on other dates can be dropped off with the Selectmen's Office during regular office hours. The Town Hall is open Monday 8 a.m.-12, 1-7 p.m. & Tuesday-Thursday from 8am-4pm. The Planning Office is open Tuesday's and Thursday's from 8am to 4pm.

Please note that PREA fees collected for professional review either by our Town Engineer, Town Environmental Consultant or Town Attorney are to be determined by the Planning Office Staff. At time of final approval, recording fees shall be collected by Planning Office Staff and the amounts shall be determined by the Rockingham County Registry of Deeds.
