

**Transfer Station
 Guidelines
 and Regulations**

Welcome

The Sandown Transfer Station provides disposal Services to residents of Sandown, NH for disposal of household trash, yard waste and other residential waste.

The State Department of Environmental Services mandates that transfer stations be operated to strict guidelines. The old days of the 'dump' are long gone. It is important that all waste be disposed of properly. PLEASE READ THIS HANDOUT. It contains important information about the proper disposal of your waste.

The Sandown Board of Selectmen has hired attendants to oversee the proper operation of the transfer station. Senior transfer station operators must learn the regulations and be certified by the State of New Hampshire.

Please listen to the attendants' instructions. If you have a question, please ask. There are many changes that are forced upon us in the disposal of waste and not only is it right for our environment it is the law!

Permits

All residents are required to have a disposal permit to use the transfer station. The resident must provide to the attendant the car registration issued to the resident in the Town of Sandown. The attendant will apply a permit sticker, at no charge, to each resident's car.

To better curb illegal dumping and commercial dumping, the attendant may ask that you provide some other type of documentation that the waste is generated in the town (i.e., building permit or special disposal permit).

A special disposal permit will be required if a resident is using another vehicle other than their own, if the resident has hired someone to dispose of the waste or if you are a new resident waiting to renew your registration in Sandown. Permits can be obtained and approved at the Selectmen's office and must be presented to the attendant at the transfer station.

Recyclables

Glass, bottles and plastic are recycled as co-mingled. Do not include your plastic bags.

Cans: Please put in designated container. Can recycling is generating revenue for the town.

Fiber: Newspapers, cardboard, office paper, junk mail, magazines, chipboard boxes (food boxes, etc.) are all recyclable and should be placed in the fiber trailer. These items are not only kept out of the landfill, but the town receives revenue for recycling them.

Motor Oil: Please see an attendant who will dispose of the motor oil for you in a separate tank.

Clothes, Shoes and Small Toys: In combination with Planet Aid, clothing, shoes, handbags and small toys can be recycled in the drop off bin. No furniture or mattresses and please put all donations in plastic bags.

Rechargeable Batteries and Home Thermostats: Only rechargeable batteries can be recycled. Non-rechargeable and alkaline batteries are not accepted. Home thermostats can now be recycled.

Contractors: please note-no dumping. Please use the Raymond landfill unless permit and prior approval is obtained. See transfer station supervisor. Supervisor has the right to refuse all loads.

Metals: Metals are collected separately, and the metal pile is located at the back area of the transfer station. Please see material disposal list for details.

Non-Recyclables

General household waste is to be disposed of in any of the 2 compactors. Please be considerate of others and stop and wait at the sign for the person in front of you to finish. This is a safety concern as well. Some items that are too big or pose a concern if placed in the compactors will be required to be disposed of into one of the open-top containers. Please ask the attendant.

DO NOT PUT LOOSE TRASH ON TOP OF THE RAM. THIS CAN DAMAGE THE RAM.

Yard Waste and Brush

Currently we accept grass clippings, leaves, hay bales and pine needles only for the compost pile. Please remove the yard waste from bags and dispose of the bags in the compactors with your trash.

WE DO NOT ACCEPT MANURE. The State of New Hampshire has strict guidelines regarding the burning of brush. The law permits brush only with a diameter of 5 inches or less. No wood, plywood, wafer board or cardboard will be accepted.

Bulky Waste

Bulky waste consists of couches, stuffed chairs, upholstered furniture, mattresses, and carpets. The container for these items is located at the back area. Please see attendant.

Other Items

Tires, auto batteries and propane tanks are accepted in the back area and may require a disposal fee. See the materials disposal list for details.

Hazardous Waste

Paints, pesticides, and other household hazardous wastes are not accepted at the transfer station. In order to accept household hazardous wastes, a location must be a certified hazardous waste collection site. The State of New Hampshire does not give towns this certification. We are, however, a member of the Southeast Regional Refuse District who conducts a yearly drop-off for these items. Please see the attendant for a list of items and date of the next drop-off.

Please Note: We can now accept electronics for recycling: TVs, radios, microwaves, computer monitors, stereo equipment, VCR's, cell phones, laptops, photocopiers, scanners, cameras and fluorescent bulbs are now accepted for a minimal charge.
