

Pursuant to House Bill 2 (HB2), the State portion of certain fees will be changing. HB2 amends certain statutes as listed below. Please note the effective dates differ on some sections.

Effective August 1, 2009

RSA 263:42, II – Certified copies of Registrations:

- ❖ The fee for certified copy of a registration has increased from \$ 10 to \$15

Sections of RSA 261:89 and 261:141 have been changed as follows:

- ❖ Vanity plates have increased from \$ 25 to \$ 40 per year

Section III (g) has been changed to now assess a surcharge based on the vehicle's weight. This surcharge is in addition to the "normal" fees based on weight.

- ❖ 0 – 5000 lbs = \$ 30.00 surcharge
- ❖ 5001 – 10,000 lbs = \$ 45.00 surcharge
- ❖ 10,001 – 26,000 lbs = \$ 55.00 surcharge
- ❖ 26,001 – 73,280 lbs = \$ 75.00 surcharge

Section III (j) for semi-trailers and utility trailers has changed.

- ❖ 0 – 1000 lbs has increased from \$ 3.00 to \$ 8.00
- ❖ 1001 – 1500 lbs has increased from \$ 6.00 to \$ 11.00
- ❖ 1501 – 3000 lbs has increased from \$ 12.00 to \$ 17.00
- ❖ 3001 – 5000 lbs has increased from \$ 24.00 to \$ 34.00
- ❖ 5001 – 8000 lbs has increased from \$ 36.00 to \$ 46.00
- ❖ 8001 lbs & greater has increased from .60 per hundred lbs gross weight to .90 per hundred pounds gross weight

Section III (o) for Motorcycles has changed

- ❖ The fee has increased from \$ 15.00 to \$ 25.00

Please note that the \$ 1.00 fee for the motorcycle rider safety fund shall still be charged

Section VII (b) Transfer Fees

- ❖ The transfer fee has increased from \$ 10.00 to \$ 25.00

EFFECTIVE AUGUST 28, 2009

RSA 270-E:5 Boat Registration Fees

- ❖ Up to and including 16 feet has increased from \$ 12.00 to \$ 24.00
- ❖ 16.1 feet to 21 feet has increased from \$ 17.00 to \$ 34.00
- ❖ 21.1 feet to 30 feet has increased from \$ 26.00 to \$ 52.00
- ❖ 30.1 feet to 45 feet has increased from \$ 36.00 to 72.00
- ❖ 45.1 feet and over has increased from \$ 46.00 to 92.00
- ❖ The lake restoration and preservation fee has increased from \$ 5.00 to \$ 7.50
- ❖ The boat agent fee has increased from \$ 1.50 to \$ 5.00
- ❖ RSA 270-E:10 Boat Registration Transfer Fees
- ❖ The minimum fee to transfer a boat registration has increased from \$ 3.00 to \$5.00
